1. Acknowledge that a horse may, without warning or any apparent cause, buck, stumble, fall, rear, bite, kick, run, make	
unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, saddles or bridles may lo	osen
or break – all of which may cause the rider to fall or be jolted, resulting in serious injury or death.	
2. ACKNOWLEDGE THAT HORSEBACK ARCHERY IS AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS	
MAY CAUSE SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior	of
horses, regardless of their training and past performance.	
3. Voluntarily assume the risk and danger of injury or death inherent in the use of the horse, equipment and gear at activities	and
events affiliated with The Mounted Archery Association of the Americas, hereafter known as MA3.
